The FCA Summit will bring together people and organizations from across the state and locally in a World Café dialogue on civic health that will be informed by case studies, civic thought leader presentations and each other. Participants will identify practical strategies for engaging the whole community in both measuring civic health and implementing actions to improve community wellbeing.

Civic health relates to the overall wellbeing of residents, neighborhoods, and communities, using their voice to find equitable solutions to key issues where they live and work. Communities with strong indicators of civic health have higher employment rates, stronger schools, better physical health, and more responsive governments, and their residents live longer, healthier lives. The Civic Health Index's data-driven measures can help target and inform actions that can facilitate positive change for the whole community. Not since 2012 has Florida conducted a statewide civic health index analysis and report. The Florida Civic Advance wants to change that by convening key partners and allies who share our mission to strengthen the civic health of Florida communities.
